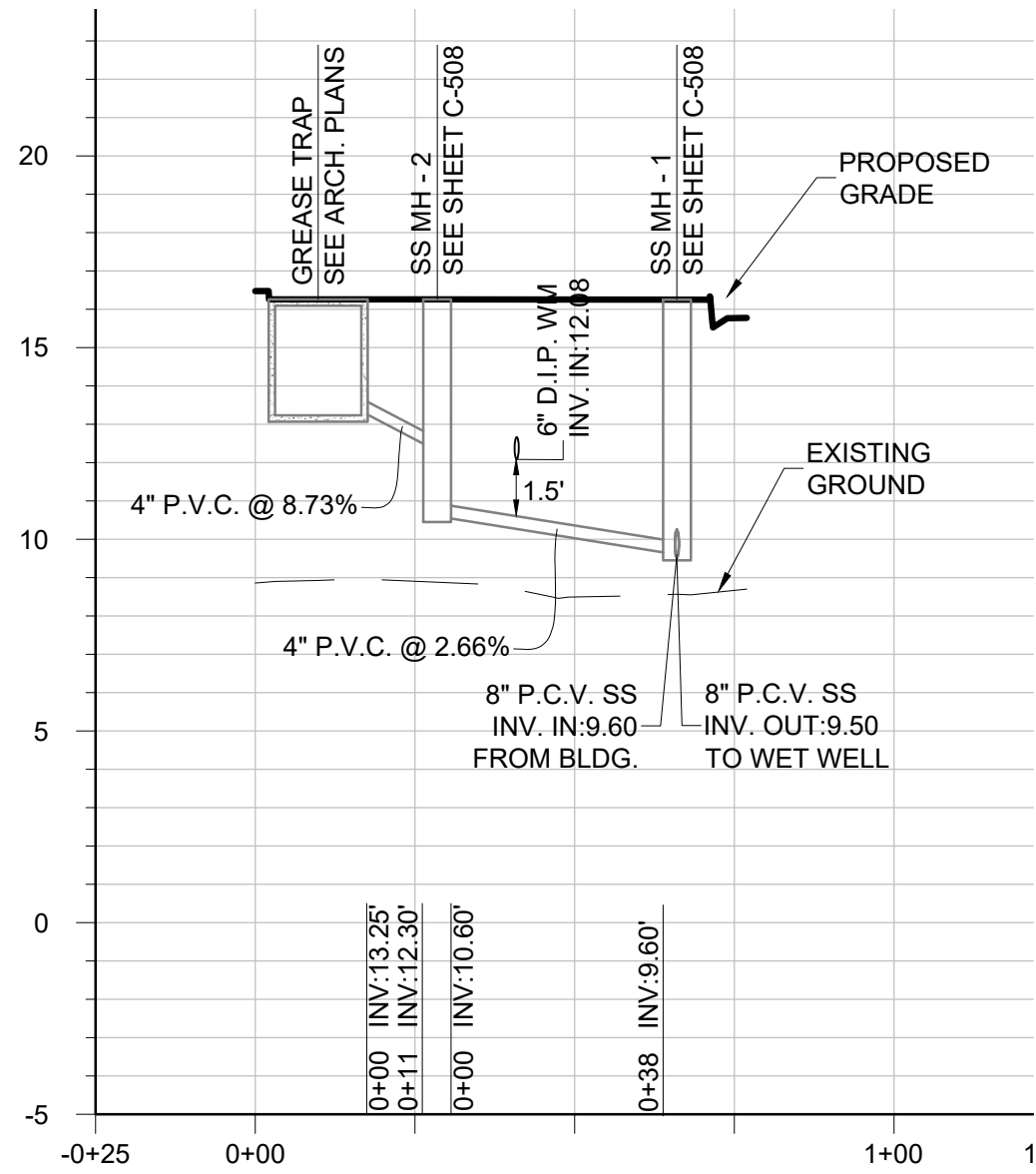

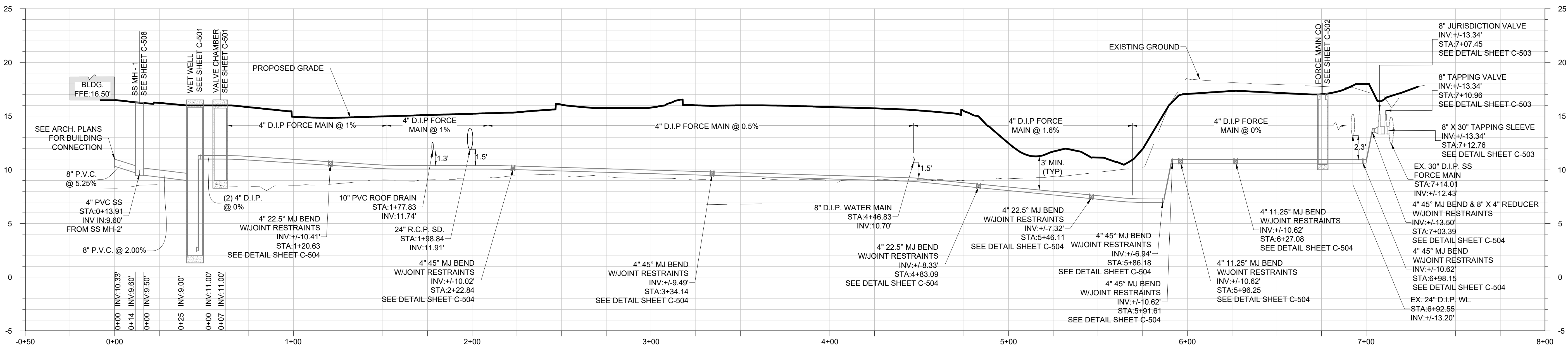


SANITARY SEWER PROFILES

SCALE: HORIZONTAL 1"=30' VERTICAL 1"=5'

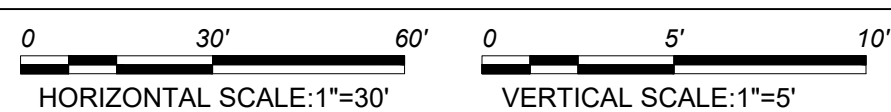


SANITARY SEWER FORCE MAIN PROFILE
